


Health Canada has released its second annual report on (MAiD) euthanasia and assisted suicide, and what it shows is alarming. From the time euthanasia was legalized in June 2016 to the end of December 2020, close to 22,000 Canadians died by lethal injection. Tragically, over 1,400 of them asked to be put to death because they were lonely. The numbers will only continue to escalate now that the euthanasia expansion Bill C-7 is law. Safeguards have been removed and those with mental illness will be able to access MAiD in 2023. Is death the best we have to offer Canada?

#### **Sex-Selective Abortion Act Defeated**

MP Cathay Wagantall's Bill C-233 to ban sex-selective abortion was defeated in the House of Commons June 2, 2021. 82 MPs voted in favour (81 Conservatives, who were allowed a free vote, and 1 Independent), 248 voted against the legislation. (See insert for how Niagara MPs voted.)

MPs who voted against Bill C-233 are clearly out of step with Canadians. Polls show the vast majority of us support a ban on sex-selective abortions.

According to MP Wagantall, it was the first time in 15 years that abortion was debated in the House. She told *We Need A Law* right after the vote that despite a disappointing result, she was very encouraged by all the MPs who voted for her bill and the numerous Canadians who got involved in the pink envelope campaign, contacting their MPs and political leaders, and educating others about the issue.



## **Texas Heartbeat Law Takes Effect**

Texas has become the first U.S. state in nearly 50 years to be allowed to protect unborn babies by banning almost all abortions. On September 1, the state heartbeat law went into effect, prohibiting abortions once an unborn baby's heartbeat is detectable, about six weeks of pregnancy. The law has the potential to save tens of thousands of babies' lives.

Up until now, state heartbeat laws have been blocked in court. But the Texas law is unique from other heartbeat laws because it includes a private enforcement mechanism that allows citizens to file lawsuits against abortionists who violate the law.

Alongside the new law, Texas state lawmakers have increased their support to assist pregnant women, and so have pro-life organizations, offering information and resources to help them and their babies. *LifeNews.com*
